Deciding to end a pregnancy, of all the choices the birth mom may have, this is the most time sensitive and permanent. Terminating a pregnancy can also be the most difficult to bear. No one should pressure a birth mom to end a pregnancy, and she shouldn't have to struggle with the decision alone. Legacy is here to help.

## **Hot Topic**

Texas House approved abortion law on Tuesday, July 9<sup>th</sup>. A final vote will be held in the Senate. If the Senate approves, the legislation would ban abortions after 20 weeks and add restrictions that would lead the closing of most abortion clinics in Texas. Other provisions would potentially require abortions to be performed at ambulatory surgical centers and would require doctors to have admitting privileges at hospitals within 30 miles of the facilities where they perform abortions.

As things begin to change in the state of Texas, it's hard to help but think this is only the beginning. What will this do for the rate of abortion? Will it put unplanned pregnant women at risk by back alley abortions? Will adoption rates or parenting rates go up? Legacy will be praying that regardless of the legal process ahead, that more women will become educated about their options and create Legacies for their child.

### Adoption – A Birth Mom's Perspective

Based on conversations with multiple birth mom's, we have found that one of the most crucial parts of what we do with our birth mothers are the relationships and bonds that we form with them. That relationship helps them feel accepted and not judged as some of the birth mothers may have felt at some point in time during their pregnancy. Being the one that offers support, both emotionally and physically is what our birth mom's really thrive for during that time in their life.

The support we offer is something very important to our birth mom's and has helped various mothers feel empowered, hopeful, and joyous for the opportunity they chose not only for their child but for themselves. Many times the choice of adoption is a second chance for them to set goals; whether it is to graduate high school, go back to college, start a career or buy a motorcycle. The opportunity these mom's have received from our support and guidance has empowered them to set goals and accomplish their dreams.

Every birth mom we work with has a different story and a different situation, however the end results is still the same. These moms feel accepted, hopeful and empowered to change themselves.

The Ins and Outs of Financing Adoption

The National Endowment of Financial Education (NEFE) has developed a booklet titled "How to Make Adoption an Affordable Option." This booklet provided information for all prospective adoptive parents regarding financial assistance, benefits, and tax breaks for all types of adoptions. It also provided a breakdown of what fee may be involved in the adoption process. The booklet it available on the NEFE website at http://publications.usa.gov/epublications/adoption/

The National Adoption Foundation has established a \$9 million revolving loan bank to provide unsecured loans to adoptive families. Payments and interest

then help other adoptive parents. The foundation has a limited program to provide grants, usually in the \$2,500 range, to assist families with adoption costs.

### **FAQ**

Can the birthmother see or hold the baby after birth? Yes. Birthmother has all rights and privileges of a parent until she signs relinquishments.

What happens if the mother refuses to give the name of the biological father? Diligent efforts must be made to determine the name and whereabouts of the biological father – but ultimately the decision to involve the birth father is her right.
